ALLOCATE SHARED UTILITIES

Shared spaces share utilities in areas like lobbies, parkades and central plants. Isolate and measure shared usage for fair allocation of costs.

Integrate with main utility meters to profile whole building energy consumption and verify utility bills.

REPORTING & BENCHMARKING (MT&R)

Divide key energy uses, such as lighting and mechanical, for LEED and BOMA BEST reporting. Track and compare tenants, buildings and usage over time.

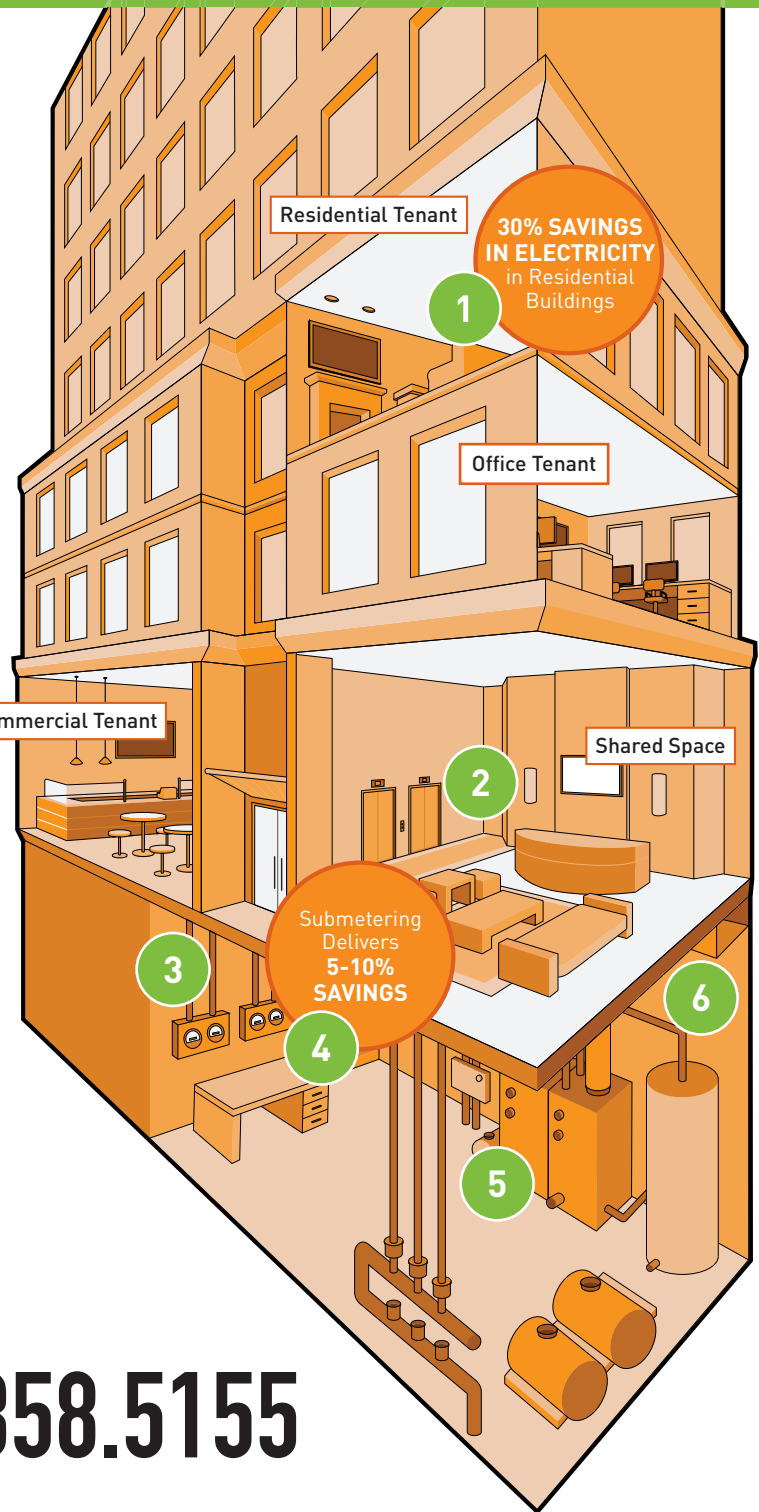
MONITOR & CONTROL
